### ORDER OF THE FIRST MINISTER AND DEPUTY FIRST MINISTER

# COMMISSIONER FOR PUBLIC APPOINTMENTS (AMENDMENT) ORDER (NORTHERN IRELAND) 2008

In exercise of the powers conferred on us by section 23(3) of the Northern Ireland Act 1998 (a):-

## Title, commencement and interpretation

- (1) This Order may be cited as the Commissioner for Public Appointments
   (Amendment) Order (Northern Ireland) 2008 and shall come into operation forthwith.
  - (2) In this Order, "the 1995 Order" means the Commissioner for Public Appointments (Northern Ireland) Order 1995 (b).
  - (3) The Interpretation Act (Northern Ireland) 1954 **(c)** shall apply to this Order as it applies to an Act of the Northern Ireland Assembly.

#### **Definitions**

2. In Article 2 of the 1995 Order in the definition of "Public Appointment" for the words "or In Part I of the Schedule to this Order, but excluding any public body listed in Part II of the Schedule to this Order" there shall be substituted the words "or in the Schedule to this Order".

#### **Public Bodies**

3. For the Schedule to the 1995 Order there shall be substituted the Schedule set out in the Schedule to this Order.

#### **EXPLANATORY NOTE**

(This note is not part of the Order)

The Commissioner for Public Appointments (Northern Ireland) Order 1995 ("the 1995 Order") as amended by the Commissioner for Public Appointments (Amendment) Order (Northern Ireland) 2001 provides that the Commissioner for Public Appointments for Northern Ireland, appointed by the First Minister and deputy First Minister acting jointly, shall have certain functions in relation to public appointments made by Northern Ireland departments to those public bodies to which the 1995 Order applies.

The 1995 Order defines public appointment as any appointment, not being an extension of an existing appointment by re-appointment or otherwise, made by a department to a public body listed in Schedule 2—to the Commissioner for Complaints (Northern Ireland) Order 1996, or in Part I of the Schedule to the 1995 Order, but excluding any public body listed in Part II of the Schedule to that Order.

This Order amends the 1995 Order by substituting the Schedule to that Order with the Schedule to this Order.
